1 The Court, having reviewed the Joint Stipulation to evaluate false and defective claims and
2 modify the hearing and briefing dates, and GOOD CAUSE APPEARING, PURSUANT TO
3 STIPULATION hereby orders that the hearing and briefing schedule is modified as follows:

- 4 1. The settlement administrator will issue an under-penalty-of-perjury questionnaire to
5 claimants who are not members of the "Healthy Awards Member program" on October
6 24, 2016.
- 7 2. Claimants must respond to the questionnaire by November 23, 2016, or their claims will
8 be discarded as false or defective.
- 9 3. The due date for the Settlement Administrator's Declaration of Compliance and Report
10 on Requests for Exclusion, Objections, and Valid Claims is moved from October 4, 2016,
11 to December 19, 2016.
- 12 4. The due date for Plaintiff's brief in support of Final Approval and Response to
13 Objections is moved from October 7, 2016, to December 23, 2016.
- 14 5. The Final Approval Hearing is moved from November 8, 2016, to January 26, 2017 at
15 2:00 PM.
- 16 6. The due date for the Opposition to Application for Fees, Costs, and Incentive Award is
17 moved from November 16, 2016, to January 18, 2017.
- 18 7. The due date for the Reply to Application for Fees, Costs, and Incentive Award is moved
19 from November 22, 2016, to January 24, 2017.
- 20 8. The Hearing on Application for Fees, Costs, and Incentive Award is moved from
21 December 8, 2016, to February 7, 2017 at 2:00 PM.
